2. STEMI ALERT EDUCATION PROJECT/Rural - David Keenan, Unity Point / Susan Brown, Mercy

Goal is to improve the process in the rural emergency rooms on identifying the STEMI patient and initiating the alert through the applicable health system.

Discussion points:

- Joint effort between Mercy and Unity Point. Form and protocol will be the same for both systems.
- Developing a tiered system: Thrombolytic vs cath lab, problem is the community hospitals do not use Thrombolytic very often and often a time delay occurs preparing for an administration.
- Discussion on how we get the message out to the facilities utilizing classroom presentations, webinars and printed materials.
- CIEMSD Operations or Training committee's may be able to assist with implementation of this training.

The committee is continuing to work on:

- Finalize the protocol and form including the brands of both health systems and contact information (One call at both facilities)
- Develop teaching outline and talking points
- Develop implementation strategy
