  - a. The following data should be presented at each meeting:
    - i. # of EMS STEMI Alerts (month and year to date)
    - ii. # of facility STEMI Alerts (month and year to date)
    - iii. # of tags used/received (month)
    - iv. Report on times (month and year to date)
    - v. Missing data components
  - b. Health systems will begin requesting complete Patient Care Reports after a STEMI (if it has not been received)
  - c. Follow-ups Discussion on changing the follow-up form on the website. Brian will evaluate defining "first medical contact
  - d. Services are encouraged to provide a "complete" patient care report
- 2. Pre Hospital "STEMI ALERT" Tag Utilization
  - a. Newton Fire Department reported as being the best at utilizing the tags so far
  - b. EMS Services are encouraged to remind their crews on tag utilization and to request follow-ups on each STEMI Alert through www.CIEMSD.org
- 3. STEMI ALERT EDUCATION PROJECT –Rural Hospitals Katy Hill, Crystal Glazebrook-Hurley and David Keenan, Unity Point and Susan Brown Mercy
  - a. Need to meet and discuss further
  - b. Possibly develop joint transfer procedure, forms and education materials
